I also especially thank our donors and partners.


As we look to the future, I am confident that together, we will continue to drive positive change and achieve great things.

INTRODUCTION

For women and girls to break barriers, claim new territories, and lead meaningful change, they must first understand, assert, and exercise their fundamental human rights. As human beings and right holders, they cannot and should not be denied these rights. Recognizing and upholding these rights lays the foundation for a fair and just society, empowering women and girls to reach their full potential—not just for their personal growth but for the betterment of their families, communities, and the world at large

THE URGENCY OF GENDER EQUALITY

Discrimination against women and girls manifests in laws, policies, and societal norms that exclude or restrict their opportunities solely on the basis of gender. Nations worldwide must commit to advancing the rights of women and girls by enacting and enforcing laws that ensure their full participation in all aspects of society and governance. Moreover, harmful gender norms must be challenged at every level, ensuring a world where women and girls can thrive without limitations.

LEGAL FRAMEWORKS PROTECTING WOMEN AND GIRLS

1. THE UNITED NATIONS CONVENTION ON THE RIGHTS OF THE CHILD (UNCRC)

The UNCRC is a landmark treaty that recognizes all children, including girls, as individuals with inherent rights. It acknowledges their unique vulnerabilities and mandates the protection and promotion of their rights, including nondiscrimination, freedom from harm and abuse, and full participation in family, social, and cultural life.

KEY PROVISIONS:

- **a. Article 3:** In all actions concerning children—whether by public or private institutions, courts, administrative authorities, or legislative bodies—the best interests of the child must be a primary consideration. This serves as a guiding principle for policies and decisions affecting children, including girls.
- **b. Nigerian Context:** Section 1 of the Child Rights Act (2003) aligns with this principle, affirming that the best interests of the child shall be paramount in all actions concerning them.

1. FUNDAMENTAL RIGHTS OF GIRLS

Women and girls are entitled to certain inalienable rights that must be upheld and protected:

Right to Life, Survival, and Development

Right to Protection from Harm

Right to Education

Right to Freedom of Expression and Speech

Right to Participation in Society

Right to Non-Discrimination

In addition, specific protections are designed to shield women and girls from harmful practices and injustices, including:

Protection from Harmful Practices: Safeguards against female genital mutilation (FGM), child marriage, and forced abortions.

Protection from Violence: The right to be free from physical, psychological, sexual, and domestic violence.

Protection from Exploitation: Protection against child labor, sexual exploitation, and human trafficking.

Protection from Discrimination: Women and girls must not be subjected to discrimination based on gender, circumstances of birth, race, nationality, or any other factor.

LEGAL BACKING:

Chapter IV, Section 42 of the Constitution of the Federal Republic of Nigeria prohibits discrimination based on gender or other factors.

Section 10 of the Nigerian Child Rights Act further reinforces protections for children, including girls, from discrimination.

1. THE CONVENTION ON THE ELIMINATION OF ALL FORMS OF DISCRIMINATION AGAINST WOMEN (CEDAW)

CEDAW is a pivotal international treaty that outlines the rights of women and provides a roadmap for achieving gender equality.

KEY ARTICLES AND THEIR SIGNIFICANCE:

Article 2: Requires states to condemn discrimination, ensure legal protections, and enact laws that eliminate gender-based inequalities.

Articles 3–6: Mandate the adoption of appropriate measures to promote the full development and advancement of women in all fields.

Articles 7–9: Guarantee women's equal rights in public and political life, including voting, political participation, and nationality rights.

Articles 10–13: Demand the elimination of gender discrimination in education, employment, healthcare, and economic life.

Article 14: Recognizes the unique struggles of rural women and their vital contributions to the economy.

Article 15: Affirms women's equality before the law.

Article 16: Ensures equality in marriage and family relations.

THE ROAD AHEAD: A CALL TO ACTION

A future where women and girls have equal opportunities is not just an ideal—it is a necessity. The journey toward rights, equality, and empowerment must be fueled by solidarity, collaboration, and an unwavering commitment to justice. To create a fair and just society, we must:

- 1. Support initiatives that empower women and girls.
- 2. Advocate for stronger policies and laws that uphold gender equality.
- 3. Demand the enforcement of existing legal protections for women and girls.

CONCLUSION

The fight for gender equality is not just about legal frameworks—it is about creating lasting change. Women and girls must speak up, take action, and lead the transformation they seek. Their voices, their leadership, and their resilience will shape a future where equality is not just a vision but a reality.

The time for change is now. Women and girls, stand up and lead the way.

ADOCACY AND COMMUNITY SENSITIZATION IN DECEMBER 2024

FIDA Nigeria, Rivers State branch attended Human Rights Day hosted by the National Human Rights Commission on the 10th of December 2024. The branch was represented by the assistant publicity secretary, Sotonye Kelechi-Nwuzi. The theme of the event was —Legal Provision of the Rights of Women and Girls: Holding Perpetrators Accountable and Planning Action for Advocacy for the





Passage of Laws on Protection of Women and Girls from Harmful Practices peculiar to the State. Highlights of the advocacy was the urgent need of reforms and enforcement of the existing laws to safeguard women and girls from harmful practices that are deeply rooted in cultural and societal norms.

On the 11th of December 2024, the chairperson of the branch, Mrs. Tamunoibuemi Life-George, along with other branch members, attended and participated in a townhall meeting organized by Action Aid to commemorate the 16 days of Activism. The Chairperson assured participants at the forum of FIDA Nigeria continued support in fighting for the rights of women and children. She reiterated that the organization services are provided free of any cost.

On the 21st of January 2025, members of the Branch and Exco paid a courtesy visit to one of our pioneer members and past chairperson of the branch, Hon. Justice Elsie Thompson.





The visit was aimed to harness the wisdom at the feet of our esteemed mother of the Branch. My Lord urged the new Exco to build in developing themselves and all members of the branch as well. She further implored the Branch to invest in self and personal development as this is the key to increase self-esteem and self-confidence of branch members.



On the 25th day of January, Members of the branch Exco on the 29th of January 2025 paid a courtesy visit to our senior, Hon. Justice Margaret Opara. My Lord expressed her belief in the new Exco and urged for increased momentum in pushing the agenda of FIDA Nigeria and indeed the state at large, forward.

On the 10th February, 2025, The Chairperson, FIDA Nigeria, Rivers State Branch, Mrs. Tamunoibuemi LifeGeorge led a delegation of members of the branch and Exco to pay a courtesy visit to the Chairman, Police Community Relations Committee (PCRC), Mr. Voke Emore, to discuss potential collaboration and strengthen ties between the police, FIDA and the community.





Key Discussions and Outcomes:

- Collaboration & Support: The Chairperson emphasized the need for partnership and familiarization, highlighting the importance of police support in FIDA's work. The Chairman assured that with the commencement of said collaborative partner, police backing is guaranteed, given their strong relationship with the Commissioner of Police (CP).
- Community Engagement: PCRC expressed enthusiasm about working with FIDA, noting that there is much to be done for the community.
- Training & Capacity Building: The Chairperson encouraged training programs for police officers and paralegals, suggesting that retired police officers be trained as paralegals to help their communities. The chairman also proposed taking this initiative to the Commissioner of Police for support.
- Strengthening Ties: It was suggested that some FIDA members be inducted into PCRC to bridge communication gaps and foster a stronger working relationship.

The Chairperson was presented with a certificate of collaboration by the Chairman as a show of his support and appreciation of the efforts FIDA Nigeria, Rivers State Branch.



Members of the Branch paid a visit to the Nigerian Police, Eleme Area. Command to bring to the notice of the commander, a case of a woman who was violently assaulted by her husband and sustained several injuries to her face and her head. The husband is now at large and absconded with the three children of the marriage in the process. In her response, the Area Commander instructed that investigations into the matter be commenced immediately and committed to ensuring that the perpetrator be brought to justice.

SPOTLIGHT CASE

On the 4th March 2025, the outcome of the branch partnership with the Police



Community Relations Committee (PCRC) paved way for further actions, as Dr. Vivian Akunesiobike and Sotonye Kelechi-Nwuzi together with the Chairman (PCRC), Mr. Voke Emore, paid a visit to the Commissioner of Police, Olugbenga Adepoju at the Police Headquarters, Moscow Road, Port Harcourt.

The reason for the visit was to report a complaint received by Sotonye Kelechi-Nwuzi and Mrs. Ibiso Briggs, regarding the assault of a young lady and her baby at the Rumuolumeni Police Station after her husband was arrested.

The complainant/victim and her baby were beaten with a belt and pushed to the ground which left the baby with a swollen eye. The Complainant's phones were also seized. In partnership with the PCRC, FIDA Nigeria, Rivers State Branch escalated the matter to the Commissioner of Police who took up the case and commenced investigations into the allegations laid against the officers of the division.

The officers in charge have been ordered to release the phone of the Complaint and further internal investigations as well as disciplinary actions against the offending officers for their actions are underway.

Members of FIDA Nigeria, Rivers State Branch extend their gratitude to the Commissioner of Police for his swift action and the Chairman of PCRC, for partnering with the branch to ensure that justice is served and the rights of women and children continue to be protected.
