On June 7, 2025, Dr. Prada Uzodimma, Esq., marks her 30th birthday not merely as a personal milestone, but as a celebration of a life dedicated to justice, education, and inclusion.

A Trailblazer in Law

With an LLB from the University of Surrey and an LLM in Maritime Law from the University of Southampton, Dr. Uzodimma has established herself as a formidable legal practitioner. Her career is highlighted by leading complex, high-stakes litigation across multiple jurisdictions, including a landmark victory in the Imo State gubernatorial election petition at the Supreme Court a testament to her legal acumen.

Championing Legal Education

Understanding the barriers faced by aspiring lawyers, Dr. Uzodimma founded the Prada Uzodimma Law School Scholarship Grant (PUSG), an initiative that has provided full tuition support to 50 underprivileged law students across Nigeria. The program, endorsed by legal luminaries such as Prof. Isa Chiroma, Director General of the Nigerian Law School, and former Attorney General Abubakar Malami, SAN, also offers mentorship and practical experience through its Fireside Chat Series and Internship Program.

A Proactive Bar:

Leadership of Mazi Afam Osigwe, SAN

Since being sworn in as the 32nd President of the Nigerian Bar Association (NBA) on August 29, 2024, Mazi Afam Osigwe, SAN has demonstrated dynamic and visionary leadership. His administration has prioritized critical reforms that uplift the legal profession, promote justice, and strengthen the institutional fabric of the NBA.

1. Championing Fair Remuneration for Lawyers

As the immediate past Chairman of the NBA Remuneration Committee, President Osigwe laid the groundwork for improved earnings for legal practitioners. Unsurprisingly, his administration has made the implementation of the Legal Practitioners Remuneration Order, 2023 a central focus. Now under the leadership of Chief Emeka Obegolu, SAN, the Committee continues its efforts, but with the strong backing of a President deeply committed to ensuring that lawyers are fairly compensated for their services.

2. Building an Effective and Digitally-Driven Secretariat

One of the standout achievements of President Osigwe's leadership is the revitalization of the NBA Secretariat. With the support of the General Secretary, Dr. Mobolaji Ojibara, the Secretariat now operates with unprecedented efficiency. Lawyers now enjoy prompt delivery of stamps and seals, faster turnaround time for inquiries, and a digitally streamlined registration process for NEC meetings. The administration has also enforced compliance with the Continuing Professional Development (CPD) Programme, making it a mandatory requirement for the issuance of practicing certificates—thereby ensuring a more informed and capable Bar.

3. Pushing for Judicial Reform

President Osigwe has been a consistent and vocal advocate for judicial reform. His administration has championed the financial autonomy of the judiciary, proposed legislative amendments to improve case scheduling and management, and advocated for solutions to reduce systemic delays in the justice delivery system. These efforts are geared towards restoring public confidence in the courts and reinforcing the independence of the judiciary as a cornerstone of democracy.

4. Institutional Strengthening and Disciplinary Oversight

To promote professionalism and ethical conduct, President Osigwe has overseen reforms that enhance the internal structure of the NBA. Disciplinary committees have been established across all branches, ensuring accountability and enforcement of ethical standards. This reform has significantly boosted the credibility of the Bar and its commitment to upholding justice both within and outside the legal profession.

The health insurance application process has also been simplified, making it more accessible and encouraging wider uptake among members.

In less than a year in office, Mazi Afam Osigwe, SAN has set a new benchmark for NBA leadership marked by courage, innovation, and an unwavering commitment to the welfare of lawyers and the integrity of the legal system.
